GENERAL

Opening Remarks

Liz Hamilton

National Board Report

The Code of Disciplinary Regulations (CDR) has been revised and streamlined to enable implementation of EDGAR (Electronic Data Gathering and Anti-cheating Radar), which will be used to detect online cheating.

ACBL has become involved in fee collection for STaC games. The sanction fee will now be \$7.50 per table; the additional monies will *not* go to District 17. In the past, District 17 was charging a participation fee of \$6.50 per table and was paying \$5.20 per table, resulting in net income of \$1.20 per table.

ACBL is proposing that if a pair wants their opponents to wear masks then the requesting pair must supply the masks. This is not yet official policy.

There was a discussion regarding the efficacy of ACBL's "5/5/5" policy for sharing revenue with units.

Treasurer's Report

District 17 currently has \$65,000 invested with Schwab. Of this amount, \$25,000 is in a CD that matures in May; the balance is in treasury bills. Motion by Jennifer O'Neill to purchase a two-year CD yielding 4.75% using funds that are currently invested in treasury bills. Seconded by Liz Hamilton. Carried unanimously. (*n.b.*, 4.75% rate was correct at the time of the meeting.)

Recording Approval of January 9, 2024 Minutes

NEW BUSINESS

ACBL Charity Foundation Grant Program

From Nancy Stromer (ACBL Charity Foundation President): "District 17 will receive a grant from the ACBL Charity Foundation in 2024 in the total amount of \$10,000 to distribute to no more than five separate 501(c)3 non-bridge related charities in your District. The distribution of the \$10,000 does not have to be evenly distributed among the selected charities. You may choose to give the entire grant to one charity, if you prefer." Each application must include the following information: (1) name of the charity, (2) address of the charity, (3) contact person and telephone number, (4) email address of charity, (5) EIN or Tax ID number for the charity, (6) amount of the grant. Each unit may submit one grant proposal. District 17 has set a deadline of May 10, 2024 to submit grant requests. Requests will be reviewed at the May 2024 board meeting.

Free Play Guidelines

Motion by Jennifer O'Neill that the District recorder, assistant District recorder, two website assistants, marketing assistant, NAP chair, and GNT/STaC chair each receive ten (10) free plays per annum. The District auditor will received four (4) free plays per annum. Seconded by Dave Baglee. Carried unanimously.
